#### DIRECTIONS

<u>From Palm Beach Airport to Hotel</u>: From airport continue on to James L Turnage Blvd, use any lane to turn left at the first cross street onto Australian Ave, after 0.2 miles turn left on to Belvedere Rd, Embassy Suites will be on your immediate right

<u>From Hotel to Palm Beach International Equestrian Center</u>: 3400 Equestrian Club Drive, Wellington, FL 33414. Head south onto Australian Ave. After 1.2 miles use right lane to take US 98 W/FL-80 W ramp to Florida's Turnpike. After 7.2 miles keep right to go onto Southern Blvd and then turn left onto FL-7/ State Road 7. After 2.1 miles turn right onto Forest Hill Blvd/FL-882. After 1.8 miles turn left onto Southshore Blvd. After 2.4 miles turn right onto Pierson Rd. After 0.4 miles turn left onto Equestrian Club Dr.
