From Hotel to Redfield Farm: 3300 NW 100TH Ave, Ocala, FL 34482

Merge onto I-75 N, after 1.9 miles take exit 352 for FL-40 toward Ocala/Silver Springs, turn left onto FL-40 W/W Silver Springs Blvd., after 7.1 miles turn right onto NW 110th Ave, after 2.4 miles the farm will be on your left
