DIRECTIONS

FROM INTERSTATE-80

I-80 West to Exit #19 Hackettstown, Allamuchy, Andover-CR5 17

At bottom of exit ramp make Left onto CR 517 South

Continue on CR 517 (will turn into High Street) for 4.8 miles (pass M&M Mars on left)

Come to traffic light in center of Hackettstown (Hackettstown Trading Post Furniture store on left)

Continue straight through the light onto Grand Avenue (CR 517 turns left at this light – do not go that direction)

Continue on Grand Avenue for about 2.5 miles (you will pass a post office on the right)

The main campus of Centenary University is one block off of Grand Avenue (Building with Gold Dome is the landmark for the campus on Jefferson St.)

Grand Avenue will go under a one lane overpass and turns into Rockport Road

One mile after the overpass, make the second left onto Airport Road

Go 1.5 miles on Airport road to a traffic light and make a Right onto CR 57 South

Make first left onto Kings Highway (492 ft)

Follow Kings Highway to the top of the Mountain (2.2 miles)

Turn right onto Pleasant Grove Road at the first stop sign on Kings Highway

Follow Pleasant Grove Road for .8 miles and turn left onto Califon Road.

Centenary University Equestrian Center is approximately 1 mile down on the left (signs are at the bottom of the

driveway)

FROM INTERSTATE-78

Take Tewksbury Exit #24 – Oldwick/Whitehouse (523/517)

Make a right at bottom of ramp – Rt. 517 North

Continue 517 North for approximately 10 miles into Long Valley.

Continue 517 North up Schooley's Mountain for another 2 miles.

Make a left onto Pleasant Grove Road (immediately after firehouse and church on left).

Continue on Pleasant Grove Road for 2-3 miles.

Make a left onto Califon Road.

Centenary University Equestrian Center is approximately 1 mile down on the left (signs are at the bottom of the driveway)

DIRECTIONS

From Newark Liberty Int'l Airport to hotel – take I-78 W, after 26 miles take exit 29 toward US 202 S/US 206 S/Somerville, merge onto I-287 S, after 2.4 miles take exit 17 onto US-202 S, after 0.2 miles take Commons Way exit, turn left onto Commons Way, after 0.8 miles turn left onto Crossing Blvd and the hotel will be on the left

From hotel to Centenary College Equestrian Center – 12-56 Califon Road, Long Valley, NJ 07853

Turn right onto Crossings Blvd, after 0.8 miles merge onto I-287 N, after 3 miles take exit 21B toward I-78 W, after 9 miles take exit 20B toward Cokesbury, after 3.8 miles turn right onto Mt. Gove Road, after 1 mile turn left onto Hoffmans Crossing Road, after 1.1 miles turn right onto High Bridge-Califon Road, after 1.6 miles turn left onto Sliker Road, after 1.4 miles turn right onto Pleasant Grove Road, after 0.3 miles turn right onto Middle Valley Road and the entrance will be on your right
