ATTENDANCE

- **Attendance is strictly limited**, on a first come, first serve basis. Please complete the online registration form in advance of the **January 12, 2024 deadline**. Available clinic spots may become filled before the early registration deadline.
- Attendees must sign in at the beginning and end of each session to receive credit for the clinic. If you arrive more than one hour later than the scheduled starting time, or leave before the scheduled adjournment, you will not receive credit for attending the clinic.
- Online registrations will receive an email follow up from USHJA staff shortly after form is submitted.
- You are required to review notebook material from USHJA prior to the clinic. Materials will be distributed two weeks in advance. You will need to print or have electronic access to it during the clinic. Notebooks will not be distributed at the clinic site unless purchased in advance.

AIRPORT

Palm Beach International Airport (PBI) – 1 mile from hotel

DIRECTIONS

FEES

\$270 = Online registration completed **on or before January 12, 2024**.

\$50 = Print and ship notebook directly to clinic **on or before January 26, 2024**.

\$75 = Print and ship notebook directly to clinic **after January 26, 2024**.

REFUND If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
