Successful completion of this virtual clinic is required as part of the Jumper Judge requirements as outlined in the [USEF Licensed Officials Policies and Procedures](#). Attendees must participate in the virtual clinic in its entirety and achieve a passing score on the exam to receive clinic credit. Notebook materials and Zoom links will be sent via email two weeks prior to the clinic. A hard copy notebook may be purchased from USHJA to ship directly to your address on file for an additional fee. The deadline to register online for the clinic is **April 19**. Officials interested in registering after this date must contact the Licensed Officials Coordinator at USHJA at 859-225-6700 to register. **Space is strictly limited.** All attendees of USHJA Licensed Officials Clinics are required to be Active/Competing members of USHJA.

- Attendance is taken at beginning of each session. Please be prepared to log on in advance of the clinic start time to sign in with USHJA staff.
- All sessions must be attended in their entirety in order to receive clinic credit.

Attire

Testing

Fees

- \$270 = Online registration for the session completed **on or before April 19**.
- \$50 = Printed notebook shipped to attendee (optional). **After April 19, all notebooks will be sent electronically.**

Refund

If a participant is unable to attend a clinic and notifies USHJA of withdrawal in writing at least fourteen days prior to the start of the clinic, 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic and the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
