## FEES

\$200 = Monday evening 'R' session, online registration completed **on or before December 21, 2023.**

\$245 = Monday evening 'R' session, online registration completed **after December 21, 2023.**

\$385 = 'r' and applicant session, online registration completed **on or before December 21, 2023.**

\$450 = 'r' and applicant session, online registration completed **after December 21, 2023.**

\$50 = Print and ship notebook directly to clinic **on or before January 5, 2024.**

\$75 = Print and ship notebook directly to clinic **after January 5, 2024.**

**REFUND** If a participant is unable to attend a clinic and notifies the United States Hunter Jumper Association of their withdrawal in writing at least fourteen days prior to the clinic, then 50% of the clinic fee will be refunded less a \$25 processing fee. If a participant withdraws from a clinic, but the position is filled from a waitlist, a full refund will be provided less a \$25 processing fee. If a participant withdraws from a clinic with less than fourteen days' notice, the clinic fee is non-refundable regardless of the waitlist status.
